Pay Revision 2014 - Insurance Medical Services Department- Scale of pay of Nursing Staff- Allowances of Other Categories- Modified- Orders Issued.

ORDER

As per the Government Order read as 1st above, orders were issued revising pay and allowances of State Government Employees and Teachers w.e.f 01.07.2014, wherein the posts of Staff Nurse Grade II, Grade I and Head Nurse in Insurance Medical Services Department were placed in the scales of pay of Rs.26500-56700, Rs.27800-59400 and Rs.30700-65400 respectively and the equivalent posts in Health Services and Medical Education Departments were placed in the scales of pay of Rs.27800-59400, Rs.29200-62400, Rs.32300-68700. The Director, Insurance Medical Services Department vide his letter read above has reported that prior to the 10th Pay Revision parity in scale of pay was allowed for Nursing Staff in Insurance Medical Services Department with similar categories in Health Services and Medical Education Departments since the qualification, method of appointment, nature of duty etc of nursing staff were the same in these three departments. He has, therefore, requested to enhance the scale of pay of Nursing Categories in Insurance Medical Services Department at par with Health Services and Medical Education Departments.

2.The Director has reported that ESI allowance has been sanctioned to Medical Officers in Insurance Medical Services Department vide G.O read as 1st above under Annexure IX - 'Compensatory allowance', but under Annexure XI - 'Non Practicing Allowance', wherein the NPA sanctioned to Medical Officers of IMS Department is also noted as 'ESI' allowance. As two separate allowances with the same name is impermissible, the Director has requested to efface the sub heading 'ESI Allowance' under Annexure XI in

the G.O read 1st above. It is also reported that Risk Allowance @ Rs.350 is sanctioned to the post of Insurance Medical Officer in the Insurance Medical Services Department. Since the post of Assistant Insurance Medical Officer is not mentioned therein, the categories of Medical Officers having designation 'Assistant Insurance Medical Officer' are not eligible for Risk allowance now. As the risk factors involved in the job of Insurance Medical Officer and Assistant Insurance Medical Officer are the same, there is no justification to deny Risk allowance to the post of Assistant Insurance Medical Officer. Hence the Director has requested to extend the benefit of Risk allowance to the category of Assistant Insurance Medical Officer too. The Director has also reported that the post of Junior Lab Attender is not existing in the Department; the post existing there is Junior Lab Assistant. Hence he has requested to modify the designation of Junior Lab Attender shown under the schedule of Risk allowance as Junior Lab Assistant.

3. Government have examined the matter in detail and are pleased to issue the following orders :

(1) The scale of pay of the posts of Staff Nurse Gr.II, Gr.I and Head Nurse in Insurance Medical Services Department is modified from Rs.26500-56700, Rs.27800-59400, Rs.30700-65400 to Rs.27800-59400, Rs.29200-62400, Rs.32300-68700 respectively w.e.f 01.07.2014.

(2) The Sub heading 'ESI Allowance' under the caption Insurance Medical Services Department in Annexure XI shown at Page 83 in the G.O read as 1st above will stand deleted.

(3) The designation 'Insurance Medical Officer' in the schedule of Risk Allowance at page 78 in the G.O read as 1st above will be replaced by 'Insurance Medical Officer/Assistant Insurance Medical Officer' and the designation 'Junior Laboratory Attender' ibid will be substituted with 'Junior Laboratory Assistant'.

4. The arrears of pay arising out of para 3(1) of this order will be notional up to 31.07.2017.




