## ORDER

As per the Government Order read 1st paper above, Government employees were permitted to avail House Building Loans from recognized financial institutions by creating Second Mortgage on the property already pledged to Government.

(2) As per the Government Order read 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> cited the cost ceiling for creating 2<sup>nd</sup> mortgage has been enhanced thrice previously. Now the Government order under 6<sup>th</sup> cited is running, accordingly cost ceiling limit stands 100 times of basic pay subject to the maximum of 25 lakh.

- (4) Government have examined the matter in detail and are pleased to order that, the total amount of House Building Advance sanctioned by Government and the loan raised by Government servants from outside financial institutions by creating second mortgage shall not exceed the cost ceiling limit of 100 times of basic pay subject to maximum of ₹ 40 lakhs. All other conditions existing in the Government Order read 4<sup>th</sup> paper above shall remains the same and will be followed.
