S. R. O. No. 425/2011.—In exercise of the powers conferred by sub-section (5) of section 1 of the Employees' State Insurance Act, 1948 (Central Act 34 of 1948), the Government of Kerala in consultation with the Employees' State Insurance Corporation and with the approval of the Central Government, and after having given notice of their intention of so doing by issue of Notification No. 21913/F3/10/LBR dated 17th December, 2010, published in the Kerala Gazette Extraordinary No. 2941 dated 28th December, 2010, as requested by the said Act, hereby extend the provisions of the said Act to the classes of establishments specified in column (1) of the Schedule annexed hereto and situated in the areas specified in column (2) thereof, with immediate effect.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government of Kerala in consultation with the Employees' State Insurance Corporation and after having given notice of their intention to do so, have decided to extend the provisions of the Employees' State Insurance Act, 1948 to the factory establishments (power using) and non-factory establishments i.e. the Shops, Hotels, Restaurants, Road Motor Transport establishments, Cinemas including preview theatres, Newspaper establishments, educational Institutions and Medical Institutions wherein ten or more persons are employed, or were employed on any day of the preceding twelve months, in the areas where the scheme has already been brought into force.

This notification is intended to achieve the above purpose.
