## ORDER

As per the G.O. read 3rd and 4th above Government have accorded sanction to avail the housing loan facility extended by HUDCO on optional basis up to 25 Lakh to State Government Employees who resides within TRIDA limits of 5 Panchayats namely Kalliyoor, Vilavoorkkal, Vilappil, Pallichal and Venganoor. Vide reference 5th cited the HUDCO has requested the Government to consider them for providing housing loan of ₹ 6.00 Lakh with an interest subsidy of 6.5% p.a. for a period of 15 years under CLSS to Government Employees on the following terms and conditions:

GCPT, 4/3444/2016/S-9

- The family should not own any house anywhere in India (family comprising of husband, wife and unmarried children).
- The annual family income should not exceed ₹ 6.00 Lakh.
- 3. The proposed house should be in urban areas.

Government have examined the matter in detail and are pleased to accord sanction to avail housing loan facility of ₹ 6.00 Lakh with an interest subsidy of 6.5% p.a. for a period of 15 years to Government employees in urban areas on second mortgage basis and the employees who are not completed in 5 years service, if so they desire. The monthly instalment of loan recovery would be made by respective HODs/CCOS/DDOS as the case may be from the salary of the respective employee and remitted with HUDCO on monthly basis by deducting from their salary at source.
