## <u>ORDER</u>

As per the Government Order read 2<sup>nd</sup> above, orders have been issued revising pay and allowances of State Government Employees and Teachers with effect from 01.07.2014 wherein Uniform Allowance at varying rates has been sanctioned to various categories of employees who are required to wear uniform during duty time. Hospital Attendants of Insurance Medical Services Department working in Laboratories, X-Ray unit and sanatorium for chest diseases Mulankunnathukavu and VD section alone are allowed, inter alia, Uniform Allowance @ Rs.2000 per annum. The Director of Insurance Medical Services vide his letter read above has reported that the entire Hospital Attendants under his department have to wear uniform while on duty and they were allowed Uniform Allowance prior to the 10<sup>th</sup> Pay Revision by virtue of the special provision provided under para 22 of

the G.O read as 1<sup>st</sup> above. The Director has further reported that wearing uniform is inevitable to the entire Hospital Attendants for performance of their duties, but now they could not be paid Uniform Allowance for want of enabling provision in the Government Order read as 2<sup>nd</sup> above. Hence he has requested to sanction Uniform Allowance to the Hospital Attendants under Insurance Medical Services Department.

2. Government have examined the matter in detail and are pleased to sanction Uniform Allowance @ Rs.2000/- per annum to the category of Hospital Attendants in Insurance Medical Services Department w.e.f 01.04.2017.
