ORDER

As per the letters read above the Director of Insurance Medical Services, has informed that Employees State Insurance Corporation has agreed to open new ESI Dispensaries at Nedumangadu in Thiruvananthapuram District and Pala at Kottayam District if State Government have granted its consent and create necessary posts. Accordingly Government have examined the feasibility to start the dispensaries and it is seen that starting of ESI dispensaries in Nedumangadu and Pala will be most beneficial to the ESI beneficiaries in the region. It is also seen that the expenditure for the new dispensaries for the first three years will be completely bear by the ESI Corporation and thereafter will be shared by the ESI Corporation and the State Government on 7:1 ratio. As such the financial commitment on the part of the State is minimal. Therefore Government are pleased to accord sanction to start one Doctor type ESI dispensaries at Nedumangadu and Pala as recommended by the Director of Insurance Medical Services.

Following posts are also created for the functioning of the above said dispensaries.
