<sup>#</sup>For works related to day to day maintenance of buildings and day to day O & M of Services / MEPs. For other works related to ARM, payment to be made by RDs.

Day to day maintenance of buildings and day to day operation and maintenance of services / MEPs would be done under the aegis of hospital administration failing which by RO. However, the periodic ARM work of buildings shall be done by RO. Annual maintenance of equipments and plants related to services shall be done by RO in consultation with hospital administration.
