Sir/Madam,

I am directed to inform that in order to promote the AYUSH services in hospitals and dispensaries of ESIC as well as ESIS, the ESIC sub-committee on AYUSH headed by Secretary (L&E) approved for implementation.

1. Boards should be erected in prominent places like entrance and inside of hospital/dispensary regarding the availability of AYUSH services for information to IPs and their families.
2. The Posters be prepared and printed on the strengths of the AYUSH System in English and local language and displayed in different localities of the hospital and dispensary.
3. Interactive clinical meetings be conducted for AYUSH and other doctors periodically on difficult diseases to find solutions for the benefit of IPs and their families.
4. Space (at least three rooms, each of 12'X 15') for Panchakarma and 5-10 beds for IPD as per the need, may be provided in ESIC hospitals.
5. The AYUSH personnel can be provided training in Panchakarma, Ksharsutra and Para surgical techniques, if they are doing these therapies and requiring the training.
6. The OPD in respective AYUSH units should be a minimum of 40 per day. In case of the OPD sixty or more per day another doctor of the same system can be engaged. In case of ESIS dispensaries/Hospitals, if the OPD is less than 25 it will be closed unless the state government wants to continue on its own funds outside ESI scheme.
7. It may be noted that the nomenclature has been changed to ISM to AYUSH in ESI.
8. Maximum range of AYUSH drugs may be made available in ESIC and ESIS Hospitals and Dispensaries, as per the ESI rate contract, if in force.
9. The working hours of Ayush units in ESIC Dispensaries be changed from 9.00 A.M. - 4.00 P.M. to 7.30 A.M. - 1.30 P.M. as in the case of allopathy. If the total OPD is more than 60 per day another doctor of same system may be engaged on contractual basis for evening OPD. In case of ESIS dispensaries, the timings of AYUSH units may be followed as in the case of allopathy.

You are requested to implement these instructions with immediate effect and report compliance.
