As per Government Order, **Kerala State Co-Operative Hospital Complex and Centre for Advanced Medical Services Limited, Pariyaram, Kannur** had been empanelled for providing specialty services to ESI beneficiaries and the service has been continuing. Treatment facilities were provided on credit basis even without renewing the agreement. Now the hospital has requested to renew the agreement with retrospective effect vide letter 2nd read above. As per letter read 3rd above, they have submitted agreement for renewal.

Only a few number of hospitals are empanelled for specialty treatment in Kannur District. Inorder to provide continuous treatment to IPs, it is decided to renew the agreement. Considering the above mentioned facts, **Kerala State Co-Operative Hospital Complex and Centre for Advanced Medical Services Limited, Pariyaram, Kannur** is hereby empanelled for giving the following specialty services to ESI beneficiaries at CGHS rates from **15.07.2017** to **14.07.2019** subject to the approval of next State Executive Committee.

Lab investigations for Out Patient cases, on specific referral from ESI Dispensary/ESI Hospital


