Dr.Bijoy Chanda Pillai Karikkineth was advised by the Kerala Public Service Commission for appointment to the post of Assistant Insurance Medical Officer as per the first paper above and he was appointed as AIMO in Insurance Medical Services Department as per order 2nd read above. His provisional appointment in the cadre of AIMO was regularized with effect from 04.09.2014 FN ,as on the date of joining duty as per order read 3rd above. He was placed on probation for a period of two years on duty within a continuous period of three years from the date of regularization of appointment to determine his suitability to hold the post to which he is appointed.

As per the letter 4th read above,Accountant General Kerala has informed that Dr.Bijoy Chanda Pillai Karikkineth has not availed any leave other than casual leave during the period of probation.

He acquired test qualification only on 02.02.2017 .Hence the period of probation has been extended upto 02.02.2017

No disciplinary action is initiated against him during the period ,and his work and conduct is satisfactory during the period of probation .


