The candidate should produce all relevant records in proof of date of birth, qualifications, Registration and Medical Fitness Certificate as prescribed in G.O.(P) No: 20/2011/P & ARD dated, 30/06/2011 before the Regional Deputy Director, Insurance Medical Services concerned and he/she should obtain verification report before joining duty and the same should be produced to the Head of Institution to which they are posted.

The Regional Deputy Director should satisfy himself about the identity of each candidate before he is allowed to join duty. For the purpose, a copy of One Time Verification Certificate which includes the scanned image of photo and signature of the candidate is enclosed herewith, the original of which will be produced by the candidate at the time of reporting for duty. A candidate who fails to produce original One Time Verification Certificate shall not be admitted to duty under any circumstance. The signature of the candidate and photograph may be verified and the fact recorded on the One Time Verification Certificate itself and the same may be returned to this office along with RTC. The Regional Deputy Director concerned should also obtain and forward the 'Personal Memorandum' of the candidate as stipulated in G.O.(P) No: 23/2013/P & ARD dated, 16/08/2013, to this office without fail, for sending the same to Kerala Public Service Commission for verification. If there is any discrepancy, the candidate should not be allowed to join duty and the fact should be reported to this office forthwith.

The original TCMC Registration, Non Creamy Layer Certificates & Community Certificates in respect of candidates should have verified at the time of joining duty.

The candidates advised are directed to report for duty within 15 days from the date of receipt of this order, at the respective station with medical fitness certificate as prescribed in G.O.(P) No: 20/2011/P & ARD dated, 30/06/2011. The extension of joining time will not be allowed without valid and specific reason. In the case of candidates whose community is noted in the appointment order, community certificates from the competent authority should be produced.

Those candidates who are doing their PG Courses and need extension of joining time will submit proper application for extension of joining time along with PG Course certificate and a bond for Rs.5 lakhs.

The candidate at the time of joining duty should be filled up the Annexure I form of appointment and submit the same to the Head of office for onward transmission to this directorate.

The Head of office should maintain a Service Book of the incumbent. The copy of the relevant page of the Service Book, attested, should be forwarded to this office together with Annexure I immediately on joining duty, as ordered in G.O.(P) No:20/2011/ P & ARD dated, 30/06/2011 for the purpose of verification by the Kerala Public Service Commission.

If the candidate fails to report for duty in time, the fact should be reported to this office without delay with the identification certificate of the candidate.

The RTC should be forwarded promptly.

Eligible candidates who have acquired PG qualification may submit the concerned original certificates directly to this office.


