Seniority list of Ministerial Staff of Insurance Medical Services Department as on 01-04-1994 was in dispute. Based on the then existing seniority list , DPC was convened for the select list - 2011 for the post of Senior Superintendent / Lay Secretary and Treasurer vide ref (1) . The select list of four candidates viz Sri S Ramachandran, Smt. S Ajitha, Sri P Balachandran and Sri V S Sudhakumar was provisionally approved by Government subject to final decision on the representation submitted by Sri T K Hariharaprasad , Junior Superintendent , Office of the Directorate of Insurance Medical Services. The above 4 incumbents were provisionally promoted and posted as Senior Superintendent / Lay Secretary and Treasurer in the then existing vacancies. All the incumbents joined duty except

Sri V S Sudhakumar who relinquished his provisional promotion for one year.

Subsequently Government have cancelled the seniority list of different categories of ministerial staff as well as the select list 2011 of Senior Superintendent / Lay Secretary and Treasurer vide ref (2) and (3) respectively. Government also have directed Director of Insurance Medical Services to prepare a fresh seniority list and submit the same to Government for approval. Accordingly a revised seniority list was prepared and submitted to Government vide ref(4) and the same was approved vide ref (6).

Applications filed in the Hon'ble KAT in connection with this issue was finally heard on 13/02/2013 and court passed orders on the same day. On the basis of KAT orders and the directions issued by Government from time to time , all the formalities and procedures in question were completed within the stipulated time frame and the seniority list of LDC and UDC as on 01-04-1994 of the Department was finalised and published vide order under ref (7).

Eventhough the select list 2011 of Senior Superintendent / Lay Secretary and Treasurer was cancelled by Government there was no specific direction to revert the promoted incumbents and hence they are continuing as such. But since the DPC list was cancelled ,fresh DPC meeting became mandatory and it was convened on 05/11/2013. The DPC notes duly detailing all the previous matters and disputes in the question were circulated before the DPC (Lower) with specification of the incumbents in

the field of choice as per the existing approved seniority list.

DPC has approved the following select list – 2013

The above select list was approved for promotion by Government vide ref (9) . In the above select list serial No :4 & serial No:6 are already retired from service. At present there are five vacancies of Senior Superintendent/Lay Secretary and Treasurer existing in the Department and hence the following incumbents are posted as Senior Superintendent / Lay Secretary and Treasurer in the scale of pay of Rs. 18740- 33680 in the stations noted against their names based on the seniority position.
