**Dr.Nithin V Nair**, was advised by the Kerala Public Service Commission for appointment to the post of Assistant Insurance Medical Officer as per the first paper above and he was appointed as AIMO in Insurance Medical Services Department as per order 2<sup>nd</sup> read above. His provisional appointment in the cadre of AIMO was regularized with effect from 29.07.2020 FN,as on the date of joining duty as per order read 3<sup>rd</sup> above.
