**ORDER NO.E1-419/2023/DIMS DATED: 16-10-2023**

**Dr.Krishnadas.K.V** was advised by the Kerala Public Service Commission for appointment to the post of Assistant Insurance Medical Officer as per the first paper above and he was appointed as AIMO in Insurance Medical Services Department as per order 2<sup>nd</sup> read above. His provisional appointment in the cadre of AIMO was regularized as per order read 3<sup>rd</sup> above.

He was placed on probation for a period of two years on duty within a continuous period of three years from **22.12.2018 FN** to determine his suitability to hold the post to which he is appointed.

As per the letter 4<sup>th</sup> read above, Accountant General Kerala has informed that **Dr.Krishnadas.K.V** has not availed any leave other than casual leave during the period of probation.

No disciplinary action is initiated against him during the period ,and his work and conduct is satisfactory during the period of probation .

His normal date of probation is **22.12.2020 FN** but he qualified the mandatory departmental test only in **09.05.2022** so his probation extended up to **10.05.2022.**

As per the order read 5th above, sanction was accorded to extend the probation period in respect of Dr.Krishnadas.K.V,Assistant Insurance Medical Officer, for one year from 22.12.2020 to 21.12.2021. As per the order read 6<sup>th</sup> above Government have extended the probation period from 22.12.2021 to 11.05.2022,as per KS&SSR Part II ,Rule 21 ,in order to declare his probation on 10.05.2022.

In these circumstances, Dr.Krishnadas.K.V,Assistant Insurance Medical Officer is therefore declared to have satisfactorily completed the period of probation in the cadre of Assistant Insurance Medical Officer on the Forenoon of **10.05.2022.**
