## ORDER NO.E1-1064/2023 DATED: 03-02-2024

Dr.Nirish Kumar.P was advised by the Kerala Public Service Commission for appointment to the post of Assistant Insurance Medical Officer as per the first paper above and he was appointed as AIMO in Insurance Medical Services Department as per order 2<sup>nd</sup> read above. His provisional appointment in the cadre of AIMO was regularized with effect from 19.02.2013 FN,as on the date of joining duty as per order read 3<sup>rd</sup> above.

He was placed on probation for a period of two years on duty within a continuous period of three years from 19.02.2013 to determine his suitability to hold the post to which he is appointed.

As per the letter 4<sup>th</sup> read above, Accountant General Kerala has informed that

Dr.Nirish Kumar.P has not availed any leave during the period of probation.

No disciplinary action is initiated against him during the period ,and his work and conduct is satisfactory during the period of probation .

He has not passed the department test. His date of birth is 09.11.1972 and he attained 50 years of age on 09.11.2022. Hence he is eligible for the exemption from qualifying the departmental test, mandatory for declaring probation.

In this circumstances, sanction was accorded to extend the probation period in respect of Dr.Nirish Kumar.P, ,Assistant Insurance Medical Officer, for one year from 19.02.2015 to 18.02.2016 vide order read 5th above.

As per order 6th above, Government have permitted the appointing authority to exempt the incumbent from passing the obligatory departmental tests with effect from 09.11.2022 as per the 4th proviso to Rule 13 B Part II ,Kerala State & Subordinate Service Rules ,1958.

In this circumstances, Dr.Nirish Kumar.P,Assistant Insurance Medical Officer is therefore declared to have satisfactorily completed the period of probation in the cadre of Assistant Insurance Medical Officer with effect from the Forenoon of 09.11.2022.
